

# **Black Women Best**

Black women's labor is central to everything: from the national economic and political sphere, to what's happening within our own communities and families. But *Black women* are almost never centered in any of these contexts. It was against this backdrop that Janelle Jones, the US Department of Labor's first Black woman Chief Economist, coined the term "Black Women Best," (BWB) and helped develop an <u>economic framework</u> to center Black women in policymaking — and strengthen collective prosperity and wellbeing in the process.

This spring, we partnered with the Congressional Caucus on Black Women and Girls (CCBWG) to publish <u>An Economy for All: Building a Black Women Best Legislative</u> <u>Agenda</u> and the accompanying <u>BWB Seal of Approval Scorecard</u>. These resources demonstrate a visionary, radical, and pragmatic policy agenda — and help put policymakers, organizers, and advocates on the path to actualized equity and liberation through efforts like guaranteeing income and valuing carework.

## The Importance of Confirming Judge Ketanji Brown Jackson

At the height of the fight to confirm Judge Ketanji Brown Jackson to SCOTUS, Solana partnered with <u>Inequality Media</u> to produce a video using the BWB framework to <u>explain</u> the necessity of confirming a Black woman justice who will interpret the law in ways that are truly just.



### Testimony on the Abolition of Racist Overdraft Fees

Jeremie <u>testified</u> before the House Committee on Financial Services, arguing for the abolition of racist overdraft fees and other "junk fees" that extract wealth from Black women, our families, and our communities.



#### New Black Women Best House Resolution

LibGen endorsed the <u>Black Women Best House Resolution</u>, introduced by the Congressional Caucus on Black Women and Girls (CCBWG) co-leads on the heels of Judge Jackson's confirmation.
